#### EOC O&P ALL-HAZARDS EVENTS-MGT-346

THIS COURSE PROVIDES PERSONNEL WHO COULD BE ASSIGNED TO OR WORK IN AN EMERGENCY OPERATIONS CENTER (EOC) THE SKILLS NECESSARY TO EFFECTIVELY PLAN FOR AND MANAGE LARGE-SCALE INCIDENTS BY APPLYING AND IMPLEMENTING AN ALL-HAZARDS, MULTI-DISCIPLINARY MANAGEMENT TEAM APPROACH. THE COURSE EMPHASIZES THE PLANNING, RESOURCE, AND INFORMATION MANAGEMENT PROCESSES.

THE COURSE FOCUSES ON THE ESSENTIAL DECISION-MAKING REQUIREMENTS WITHIN THE EMERGENCY OPERATIONS CENTER. THE JURISDICTIONAL TEAM WILL LEARN FROM THE EFFECTS OF INCIDENT DECISIONS WHILE WORKING IN AN EOC USING A SIMULATED, NOTIONAL JURISDICTION AS THEY RESPOND TO THE FINAL DAY'S EXERCISE.
